

SUMMARY ANNUAL REPORT

For F5, Inc. Employee Benefits Plan

This is a summary of the annual report of the F5, Inc. Employee Benefits Plan, EIN 91-1714307, Plan No. 505, for period 10/01/2024 through 09/30/2025. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

F5, Inc. has committed itself to pay certain self-insured Medical, Stop Loss, Dental, and Short-term Disability claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Sun Life Assurance Company Of Canada, Vision Service Plan, and Modern Health to pay Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 09/30/2025 were \$4,082,980.
